

APPLICATION FOR INTERBANK GIRO

1. IMPORTANT NOTES

- 1) GIRO Application is only applicable for regular premium insurance policies denominated in Singapore dollars.
- 2) The approval process for GIRO application using this application form is approximately 2 months. Until your GIRO application is approved, kindly remit premium payments directly to China Taiping Insurance (Singapore) Pte. Ltd ("CTPIS").
- 3) Once GIRO application is approved, you will need to ensure that sufficient funds are maintained in your bank account for the next scheduled deduction.
- 4) Scheduled deduction dates are fixed with the banks and cannot be changed. However, if a scheduled deduction date falls on a Public Holiday or weekend, deduction will take place on the next working day.

2. TO BE COMPLETED BY BANK ACCOUNT HOLDER

- a) I/We hereby instruct you to process instructions from CTPIS to debit my/our account to pay for my own and/or my Family member's policy(ies). **"Family Members" shall refer to spouse, children, parents and siblings (for single applicants only).**
- b) The bank is authorized to reject debit instruction from CTPIS if my/our account does not have sufficient funds and charge me/us a fee for this. You may also at your discretion allow the debit even if this results in an overdraft on the account and impose charge accordingly.
- c) This authorization will remain active until terminated with your written notification send to my/our last address known to you or upon receipt of my/our written revocation through the Insurance Company.
